**Description:**

The World Professional Association for Transgender Health (WPATH) publishes standards of care for transgender and gender non-binary (TGNB) people, which puts therapists in the unique and weighty role of attesting to a client's mental health status before they are allowed to access gender-affirming medical treatment. In this workshop, participants will learn how to evaluate a TGNB client's readiness for hormone therapy or surgery using an Informed Consent Model of transgender healthcare. Participants will also learn to write letters of support for gender-affirming medical treatment in accordance with WPATH guidelines.

**Learning Objectives:**

*After completing this workshop, participants will be able to:*

- Compare the ethical implications of practicing a Gatekeeping Model versus an Informed Consent Model of transgender healthcare when working with TGNB clients.
- Design an interview that comprehensively assesses a client's capacity to give fully informed consent to gender-affirming medical treatment.
- Create a surgery letter template that adheres to the WPATH Standards of Care, 7th and 8th Versions.

Jaclyn Lambe, PsyD (she/her) is a licensed psychologist in private practice with over a decade of specialized training and clinical experience in working with LGBTQIA+, transgender/gender non-conforming, polyamorous/CNM, and BDSM/kink communities.
